# Technical Support for Health Systems Strengthening Global Fund Round 10

The following organizations and projects are available to provide technical support to assist Global Fund applicants in preparing health system strengthening (HSS) related aspects of their Round 10 proposals, including incorporating cross-cutting HSS interventions into their proposals. Many (where noted) can also assist in implementing HSS interventions for proposals that are accepted. Please contact the organizations and projects directly for more information and for any clarifications that you may require.

While these are the entities that have come to our attention, it is only a partial list. There are other organizations and individuals available to provide assistance for HSS, including the World Health Organization (WHO) and other UN family organizations. Several organizations listed in this document can provide assistance to incorporate community systems strengthening (CSS) activities into proposals.

When seeking technical support, we recommend that you seek out individuals who are familiar with your country and who have experience developing Global Fund proposals. While the list here includes primarily Northern-based institutions, we encourage you to look to engage local expertise, such as through academic institutions, that might be able to assist with developing your proposal. We encourage you to seek support as soon as possible and ensure that consultants will fully engage stakeholders.

- Available for proposal development, grant negotiation, and grant implementation of Global Fund grants in relation to capacity development.
- Sources of Funding: Free technical assistance to organizations in partner countries. Funding provided by the German Federal Ministry for Economic Cooperation and Development (BMZ) via GTZ (German Technical Cooperation). Applicants should indicate their contributions.
- Previous Experience: BACKUP has supported the following countries in Global Fund proposal development (including multiple contracts in several cases): Round 7: Democratic Republic of Congo, Tanzania, Cambodia, Rwanda, Niger, and Pakistan. Round 8: Cambodia, Ghana, Rwanda, Ukraine, Nepal, the Gambia, Bangladesh, and Pakistan. Round 9: Burundi, Malawi, Mongolia, Panama, Paraguay, Ukraine, Southern Sudan, and Guinea. This has included support in Rounds 8 and 9 for several HSS components.

  - For non-Global Fund technical support: The Alliance Regional TS Hubs normally charge the client for the cost of the TS. Funding may also be available through grants and contracts awarded to the hub.
